

Low Carbon Building Programme

The Low Carbon Buildings Programme Phase 2 is the Government's £50m grant programme for microgeneration technologies, offering capital grants until mid 2009 to successful applicants from the public sector and charitable organisations. The main objectives are to demonstrate the potential for encouraging both energy-efficiency and microgeneration technologies in a range of public buildings, driving down costs in the process, and making the microgeneration market more sustainable.

LCBP Phase 2 is part of the UK Environmental Transformation Fund (ETF), a joint BERR/Defra fund to bring forward the demonstration and deployment of low carbon energy and energy efficiency technologies. Further information about the ETF is available from the BERR or Defra websites.

Why you should attend

This is your opportunity to take advantage of the recently increased grant levels. From 1 April 2008, all technologies under the framework (biomass systems, ground source heat pumps, solar PV, solar thermal and wind turbines) can receive grants from the LCBP at 50% of the eligible costs.

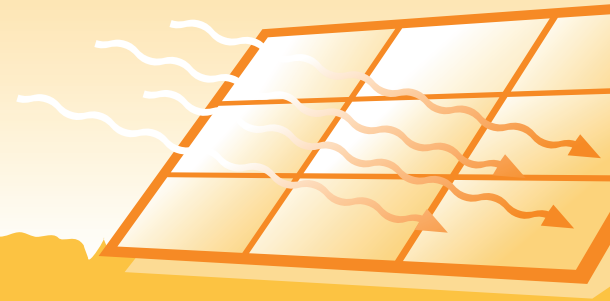

Millions of pounds in grants available to help your buildings go 'green'

Grants of up to £1 million per site are available to help you gain the benefits of renewable energy technologies.

If you are a:

- Local authority
- Housing association
- School
- Hospital
- Charitable body
- Community organisation

You could be among those eligible to apply for grants of up to £1 million for obtaining and installing renewable technologies – solar, wind, ground source heat pump and biomass.

As this funding is available for a finite period, public sector building owners and managers are being encouraged to find out more about the grants scheme to avoid missing this opportunity to reduce your buildings' carbon emissions and energy bills.

The Department for Business (BERR) and the Building Research Establishment (BRE) are to host several events across the UK, promoting the extensive grant funding available under phase 2 of the Low Carbon Buildings Programme (LCBP2).

This funding can be used for the supply and installation of any combination of the following microgeneration technologies:

- solar photovoltaics
- solar thermal hot water
- wind turbines
- ground source heat pumps
- automated wood pellet stoves
- wood fuelled boiler systems
